## **2022 Baseline Survey**

An environmental baseline for each participating organisation for 2021 has been received. There are 38 member organisations and 15 baselines have been returned. Of these, 4 clubs have carried out a review and have an action plan. One organisation - a marina has ISO14001 accreditation. A further 2 marinas have 5 Gold Anchor Accreditation which has the environment as one of the criteria. We will be carrying out this survey online at the beginning of each year so that we can chart everyone's progress in aiming for a more sustainable future.

## **The Pathway for our clubs and marine businesses to becoming more environmentally sustainable: → → →**

The RYA/British Marine Green Blue Framework takes individuals, club and businesses through 10 steps on the pathway. These can be done in any order except that the first three steps are critical in ensuring that the

Environment and Sustainability is embedded in your organisation. Below are the steps with some links you may find helpful:

### **Single Plastic Free Accreditation:**



At the November meeting, Bianca Carr gave a presentation on Single-Use Plastic Free Accreditation. The Green Blue's Kate Fortnam and the Final Straw Foundation's Bianca Carr launched the accreditation at the International Boat Show 2021.

There are three levels of certification for organisations to progress through: Bronze, Silver and Gold. Each level is determined by the organisation's dedication to eliminating single-use plastic items from their activities. This seems a good start for our organisations with something that is easily measurable through this accreditation.

**Water Quality:** There is much going on around the harbour with regards to looking at water quality and we will leave updates on this to those better placed to do this, including the usual channels for real time water quality monitoring.

The members of the Forum will continue to work with each other to reduce our own organisations' impact on the environment and water quality. We will also ensure we communicate what is happening around the harbour with regards to looking at water quality - a quick summary, but by no means an exhaustive list below:

- a. **The Conservancy** has water quality information on their [website](#). They are also running a project with the University of Sussex.
- b. **The University of Chichester and Litmus Technologies** are working together, facilitated by the Conservancy, to place a series of buoys which will monitor levels of pollution in Chichester Harbour and provide live data for industries and members of the public: [website](#)
- c. **The Clean Harbour Partnership** Rob Bailey and some of the Sailing Club's Water Quality Officers are involved in this. They are focused on Project Spotlight run by Portsmouth and Brunel Universities: [website](#)
- d. **Universities of Exeter and Portsmouth** - A study, led by the University of Exeter and also involving researchers from the University of Portsmouth, found two *Vibrio* species (bacteria) - *Vibrio rotiferianus* and *Vibrio jasicida* - that have never been recorded in UK waters before in Chichester Harbour: [website](#)
