NOTICE OF RACE

1 RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 Competitors should note that Hayling Island SC implements the RYA Racing Charter and that they will be required to undertake to sail in compliance with the Charter, which can be found at the front of the RYA rule book (Racing Rules of Sailing 2009-2012).

2 ELIGIBILITY & ENTRY

- 2.1 The regatta is open to all Solo Dinghies.
- 2.2 Eligible boats may enter at registration or in advance by post. Entry forms are available from HISC.
- 2.3 **Parent/Guardian Declarations:** All helms under 18 years of age during the event shall submit signed Parent/Guardian Declarations either by post or at registration. Declaration forms are available from HISC.

3 FEES

Entry fee per boat: £30.00

4 SCHEDULE

- 4.1 Registration: Saturday 5th June from 09:00.
- 4.2 Competitors' briefing: Saturday 5th June at 11.30
- 4.3 Dates of racing: 5th and 6th June 2010.
- 4.4 Number of races: 6 Races
- 4.5 The scheduled time of the warning signal for the first race on Saturday is 12:55 and on Sunday is 10:55.

5 SAILING INSTRUCTIONS

The sailing instructions will be available at registration.

6 SCORING

- 6.1 One race is required to be completed to constitute a series.
- 6.2 (a) When fewer than four races have been completed, a boat's series score will be the total of her race scores.
(b) When four or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

7 SUPPORT BOATS

Support boats shall register at the Race Office during the registration period.

8 PRIZES

The Tyler Trophy will be awarded to the winner.
Other prizes will be awarded based on entry numbers.

9 RIGHTS TO USE NAMES & LIKENESSES

Competitors automatically grant to the organizing authority without payment the right in perpetuity to make, use and show any motion pictures, still pictures and live, taped or filmed television of or relating to the event.

10 DISCLAIMER OF LIABILITY

Competitors are entirely responsible for their own safety, whether afloat or ashore, and nothing reduces this responsibility. It is for competitors to decide whether their boat and its helm and crew are fit to sail in the conditions that they might find. By launching or going to sea competitors confirm their boat is fit for those conditions and that they are competent to sail and compete in them. Nothing done by the organizers can reduce the responsibility of the owners and/or competitors, nor will it make the organizers responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the boat taking part in the racing. The organizers encompass everyone helping to run the event and include the organizing authority, race committee, race officer, safety officer, patrol boat personnel and beach masters. The provision of patrol boats does not relieve owners and competitors of their responsibilities.

11 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £2million per event or the equivalent.
